Upon receipt of a valid MMP member number, the completed Application form and transcripts, the MMP Program Manager will initiate the MMP certification application. The process will generally take a couple of weeks to complete, at which point, your certificate will be mailed to you.

Your certificate entitles you to use the Maintenance Management Professional (MMP) designation. As an association-issued designation, the continued use of MMP is only valid while you are a member of PEMAC in Good Standing, and therefore may not be used if you cease to be a member or lose your Good Standing within the association.

A National Register of active MMP recipients is kept on file and is published on the PEMAC Website. From time to time it may also be published in PEMAC and related literature.
